#### **OBSERVER CORPS REPORT**

Observer Corps members continue to attend school board meetings in Ozark, Nixa and Springfield and the Christian County Public Library Board meetings.

Moms for Liberty questioned the Springfield Board of Education's refusal to allow U.S. Constitutions to be distributed to all 8<sup>th</sup> grade students. Board members considered whether to add "gender identity and sexual orientation" to anti-discrimination board policies, in particular regarding school nutrition programs and food service workers. The board voted 4 -3 to not include the two phrases in the current board policies.

The Ozark School Board held its first Townhall on October 10. The format followed allowed for questioning from the audience and from online and included time limits for answers from board members. The next townhall will be held in December. Outbursts occurred several times during the October school board meeting which resulted in several attendees being asked to leave. After repeated warnings, the board was able to continue with the board agenda as written.

#### VOTER SERVICES UPDATE

**Voter Registration**: September ended with registration tabling at Ozark High School and Ozark Innovations Center, the O'Reilly Center For Hope, the Fairbanks Fall Festival, the C-Street CultureFest and the Farmers' Markets. October tabling continued with two more Farmers' Markets, Soak Up Springfield, The PTTP's Voting Fair, the Naturalization Ceremony, the CASA Youth Resource Fair, the KY3 sponsored Seminole Holland Block Party and we were present during the Sierra Club's Sustainability 101 presentation and at the O'Reilly Center for Hope. So far, the League and PTTP have registered some 360 folks. At this time, we have six tabling events scheduled during November.

**Education and Advocacy**: Our collaboration with NAACP and Faith Voices continued with a second "Supporting Democracy: One Vote at a Time" presentation made to Faith Voice members. And a discussion with some of the Rare Breed youth provided insight into the issues they face as the result of housing insecurity as well as where local support can be found.

**PTTP**: Paws to the Polls celebrated Voter Awareness Week; Oct 16 – 19, 2023, with a Voter Fair held on Wednesday. Voter registration/education tabling events and other activities occurred on the MSU campus all four days. PTTP members made a presentation on voting to PROMO (LGBTO advocacy group), hosted a Trivia Night, and sponsored a social media contest. Elected officials from Greene County, including SPS school board and city council members, county elected officials and local state legislators were invited to attend the Voting Fair, eat pizza, and talk informally with students about their roles as elected officials. The County Clerk's Office had both the DS200 vote tabulating machine and the Express Vote machine on hand to provide students with hands-on experience with both machines. 78 students registered to vote during the four days.

#### RIGHT TO READ COALITION

The LWVMO Board and our local Board have recently voted to join the Missouri Right to Read Coalition. As highlighted in the most recent LWV MO Voter, "This statewide coalition wants Missouri's libraries to remain as an open, accessible resource for books and other materials available free of charge to the public. The coalition has just recently been formed to address concerns about recent actions that lead to censorship of materials. Libraries have collection development policies that are followed by trained librarians and educators to purchase materials. Parents always have the right to determine which materials their own children can access, but not to determine the selection for other people's children. The League's position has long been supportive of public libraries and the role they play as a major source of knowledge and information necessary for informed, active participation in a democratic society."

## SUPPORT THE HEALTHY FAMILIES & MINIMUM WAGE PETITION

The LWVMO Board has voted to fully support the Healthy Families and Minimum Wage petition which will put the following questions on a 2024 ballot. Shall Missouri law be amended to: increase minimum wage to \$13.75 in January 2025 and to \$15 by 2026, with CPI adjustments starting in 2027; and require employers to provide one hour of earned paid sick leave for every 30 hours worked?

Exemptions are provided for educational, governmental, political entities and for employers with less than \$500,000 in annual gross sales revenue. Women, people of color, and part-time workers are disproportionately impacted by low wages and lack of paid sick leave. These proposed improvements fit more than one of LWV's policy priorities. Petitions, sponsored by Jobs with Justice, will be available for signing at several of our upcoming meetings.

League of Women Voters getting out the vote in 1955

Springfield-Greene County Library District For the News-Leader

Fifteen cars were scheduled to participate in the 'Get Out the Votes' parade sponsored by the League of Women Voters.



The plan was to drive through the northside business district and then the downtown area in the morning and wind their way through residential neighborhoods in the afternoon. The purpose of the

campaign was to urge people to vote on a sewer bond at the upcoming Sept. 13, 1955 election.
