## PAWS TO POLLS

Paws to the Polls was invited to serve on a panel for "Becoming an Informed and Active Citizen" for Leadership Springfield Academy on December 5, 2023, at the CASA Headquarters. Zion Riffe-Stevens (graduate assistant for Paws to the Polls) featured prominently on the panel as he talked to the high school students about his experience with civic engagement and how his perspective changed when he became old enough to vote. Paws to the Polls is deeply invested in increasing voter access and promoting civic engagement. One example of their advocacy efforts is through trips to the Missouri State Capitol. Their fourth such trip took place on February 13th; the group met with ten legislators in their offices and was recognized by Crystal Quade on the House floor.

The purpose of this trip was advocate for three House bills that would expand voter access:

 HB 1927 would restore access to voting for those currently on probation and parole, after they have served their time. When people on probation and parole are allowed to vote and

- engage with their communities, it reduces recidivism rates.
- HB 2379 would allow restoring of university
  IDs as valid for voting, as could be until a
  Missouri House bill was signed into law in 2022.
  This is especially important for our out-of-state
  students so they can vote here in Greene County
  while they study and reside in our community.
- HB 2510 would create provisions for automatic voter registration for U.S. citizens in Missouri through information via the DMV, increasing the number of registered voters and make voting more accessible.

For the third semester in a row, Paws to the Polls partnered with the League of Women Voters of



## **PETITIONS**

Reproductive Freedom Initiative Petition: After more than six months of attacks, litigation and delays following the filing of the constitutional amendment, Missourians for Constitutional Freedom (MCF) is finally able to move forward to begin collecting signatures for Version 086

THE OFFICIAL BALLOT SUMMARY is as follows: Do you want to amend the Missouri Constitution to:

- establish a right to make decisions about reproductive health care, including abortion and contraceptives, with any governmental interference of that right presumed invalid;
- remove Missouri's ban on abortion;
- allow regulation of reproductive health care to improve or maintain the health of the patient;
- require the government not to discriminate, in government programs, funding, and other activities, against persons providing or obtaining reproductive health care; and
- allow abortion to be restricted or banned after Fetal Viability except to protect the life or health of the woman?

"The deliberate tactics being used by politicians to stop the voice of the people on this issue foretells a troubling precedent for future ballot issues," says LWVMO President Marilyn McLeod.

The LWVMO is joining other groups supportive of this IP to begin collecting the necessary 171,000 signatures by May 5 to get this IP on the Nov 2024 ballot. If you would like to help, contact Kay Park at ReproRights@lwvstl.org.

The LWVUS position on reproductive choices was approved in January 1983: The League of Women Voters of the United States believes that public policy in a pluralistic society must affirm the constitutional right of privacy of the individual to make reproductive choices.

Petitions will be available at our meetings until the May 5 deadline for submitting signatures.

Also, our committee initiated support for a change to the Clean Water Commission policy for a majority of citizens to hold seats on this commission. The Board voted to support this action, and then Sherry Buchanan contacted Marilyn McCleod to attain state support. We gained that support, thanks to Sherry's persistence and a lot of emails. Many thanks to everyone on the board for supporting this action.

## VOTER SERVICES UPDATE

In anticipation of the March 6 new voter registration deadline and the April 2 Municipal elections, registrars and Paws will have been available or will be available through March 5 for a total of twenty-one events. Registration opportunities have occurred at all 6 Springfield high schools and at two locations for Ozark high school students. We were present at the NAACP Birthday Party, during Taxapalooza and at Harmony House. An afternoon was spent at the Fair Grove Branch Library and events are scheduled to take place the O'Reilly Center Day of Hope, the Township Senior Living Community, Eden Village 1 and 2, at the Glo Center, during the Strafford Transition Fair and during the March 5 SPS University event. We are on a recurring schedule for both the Center of Hope and Harmony. The April 2 Election cards are in the process of distribution, and we are now able to educate voters as to specifically "What's on my Ballot" via the Office of the Secretary of State.

The League participated in the MLK Voter Registration Town Hall sponsored by Sigma Nu Lambda-Alpha Phi Alpha as well as the first of the History Museum's "Civics on the Square" education programs. This program provides an opportunity for girl scouts to earn the Senior Behind the Ballot badge.

Paws to the Polls students were present during five of the six SPS registration events as well as during the town hall and the girl scout badge program. The League's
