Simply type in your address and it will populate a ballot with only the candidates and ballot issues for your precinct. The Voter's Guide features county-level races, state representative and state senator contests, statewide races for Missouri, U.S. senator, and U.S. representative, and information on the judges up for retention. Summaries and explanations of the six ballot issues were provided by the League of Women Voters of Missouri.

EDUCATION COMMITTEE UPDATE

The next education committee meeting will be Wednesday, Nov. 20, **12:00-1:00** (please note the time change!) at the Brentwood Library. Our plan is to look at how other states are faring with school voucher programs now that Missouri has its own version.

Also of interest to the education committee is the public library situation in Christian County. A lawsuit investigating the violation of board procedures and Sunshine Law violations in the ousting of board president Allison Tuckness during the Sept. board meeting (News-Leader article) is ongoing. The Oct. 22 board meeting began with the resignation of Tuckness (News-Leader article). During the public comment session, one citizen declared newly elected board president Echo Schneider unfit for office due to her comments in an online video. The full video of her comments and "Take Back Public Libraries" plan is available on a website hosted by local grassroots organization U-turn in Education. U-turn in Education touts itself as a group of people who "resist censorship and support public education and a wide breadth of educational experiences for all." The education committee and Observer Corp will continue to monitor, and Christian County citizens are encouraged to become informed about what is happening to their public library. HOW THE ELECTORAL COLLEGE WORKS

Next week, we'll cast our votes — and then the Electoral College will select our president.

Here's how the Electoral College works:

- 1. You cast your vote;
- 2. Election workers determine which candidate won the popular vote in your state (or DC);
- 3. The Electoral College representatives from your state/DC vote for president *on your behalf*, casting their ballots for your state/DC's popular vote winner;
- 4. The candidate who earns 270 or more votes is elected president.

LWVMO POSITION ON STATEWIDE BALLOT ISSUES

See below for a summary of LWVMO's position on three statewide ballot issues. It was published as a letter to the editor in the *Columbia Missourian* on Oct. 15.

League of Women Voters issues endorsements on 2 ballot measures, opposes Amendment 7

For more than a century, the nonpartisan League of Women Voters has studied public policy issues and when consensus is reached by the membership, may advance a position on relevant issues that come before the public.

The League of Women Voters of Missouri has taken positions on three of the six ballot measures on the November General Election ballot.

Amendment 3

We support Amendment 3 for reproductive freedom. It protects the right of privacy in reproductive choice, would overturn Missouri's current strict law on abortion that has only an exception for the life of the mother, and it would guarantee protections for related reproductive issues. Our support for this measure is based on our official and longstanding position: "public policy in a pluralistic society must affirm the constitutional right of privacy of the individual to make reproductive choices." Vote "Yes" on Amendment 3.

Proposition A

We support Proposition A for minimum wage and earned sick leave because we support programs and policies to prevent or reduce poverty and to promote self-sufficiency for individuals and families. Vote "Yes" on Proposition A.

Amendment 7

We oppose Amendment 7 because it creates restrictions that would prevent voters in cities and counties from choosing their local voting practices in the future. It also includes unnecessary and misleading "ballot candy" wording about who can vote. The Missouri Constitution already specifies U.S. citizenship is a necessary qualification to vote. Vote "No" on Amendment 7.
